Bourne's Energy adheres to the guidelines set forth in the Federal Equal Opportunity Credit Act regarding discriminatory practices in dealing with consumer credit. Notwithstanding any contrary provision of law, Bourne's Energy may bring legal action against a customer for breaching the terms of this agreement. All costs associated with enforcement of these terms will be the responsibility of the customer. The rights and obligations of both parties in billing disputes shall be subject to the requirements and exceptions outlined in the Federal Truth in Lending Act. Should any provision of this agreement be invalid or unenforceable, the validity or enforceability of any of the remaining terms shall not be affected.
