



American Rescue Plan Act (ARPA) Heating with Biodiesel Pilot Biodiesel Heating Fuel Income-eligible Incentive Voucher Application

VOUCHER PROCESS

1. Customer connects with participating Fuel Dealer. **Participating Fuel Dealer applies on customer's behalf (submits this voucher application) for Biodiesel Heating Fuel Income-eligible Incentive BEFORE system inspection and fuel delivery to confirm customer eligibility.**
2. RERC reviews application.
3. RERC directs customer to third party to complete income verification.
4. RERC receives result of income verification and determines incentive amount, if any.
5. If RERC approves incentive, customer and Fuel Dealer receive approval & voucher for Biodiesel Heating Fuel Income-eligible Incentive.
6. Fuel Dealer conducts system inspection, and if heating system is eligible provides fuel delivery and any heating system adjustments required for participation then submits voucher with detailed invoice.
7. Fuel Dealer receives a payment from the CEDF on behalf of the customer.

I understand that the incentive will be **paid directly to the Participating Fuel Dealer**, *only after* the Participating Fuel Dealer has submitted the voucher final documentation and received final approval, including any necessary site visits, and is subject to change based on final delivery cost and fund availability. I also understand that the benefit of the incentive is mine and must be transferred from the Participating Fuel Dealer to me in a manner that is agreeable to both parties. By claiming this incentive, I confirm that I have been fully informed regarding the use and risks of using and storing biodiesel for heating in my home heating system, and my fuel dealer's emergency services. I fully accept the risks and responsibility for using biodiesel and services provided by my fuel dealer. I certify that neither the Clean Energy Development Fund nor the State of Vermont has any liability or responsibility for my use of biodiesel for heating my home under the SSREIP. I understand that I will receive a post-installation survey from SSREIP and that I am expected to complete it and return it to the SSREIP.
